A. F. of L. Executive Council Urged to Consider Office Workers International Charter at January Meeting

The regular December meeting of our local, after hearing the full report of our convention delegate, instructed the officers to write each member of the A. F. of L. Executive Council requesting the council to consider this matter at its regular January meeting and to hear from a representative of our local at that time. The full content of the letter sent on December 23, 1941, to President William Green, Secretary-Treasurer George Meany, and all members of the Executive Council fol-

Dear Sir and Brother:

At the convention of the American Federation of Labor at Seattle, Wash., during October of this year consideration was given to five resolutions presented to the convention in connection with the establishment of an international union of office workers. These five resolutions were all referred to the organization committee of the convention and the report of the organization committee in connection with these resolutions was unanimously adopted by the convention.

The organization committee's recommendation, which was unanimously adopted, was as follows:

"These five resolutions are upon the general subject matter of a 'national organization for office workers.'

"Your committee concurs in the intent and purpose contained in all these resolutions, and recommends that they be referred to the Executive Council of the American Federation of Labor for further consideration and investigation, so that the question of jurisdiction, maintenance and support, etc., may be established before a national or international union charter is granted to office workers.

"The committee further recommends that this be done by the Executive Council at the earliest possible opportunity."

Office Employes Union No. 11773 at its regular December meeting instructed its officers to work toward the establishment of an international union for office workers and directed that the local union request the Executive Council of the American Federation of Labor to hear from a representative of our local union in connection with the Executive Council's consideration of this matter at its regular meeting commencing January 12, 1942.

Office Employes Union No. 11773 respectfully requests that the Executive Council of the American Federation of Labor place on its agenda for consideration at its January meeting the matters which were referred to it in the abovequoted recommendation of the convention's organization committee, which recommendation was unanimously adopted. Our local union and its officers stand ready to cooperate in every possible way with the Executive Council and we trust that the Executive Council will give our representatives an opportunity to be heard during the council's January session in connection with this matter.
