### MING ADDRESSES JULY MEETING

Brother S. P. Ming, the President of the International Council of Grain Processors, was a guest at our regular July meeting. Brother Ming spoke to the meeting and pointed out the recent advancements made by his organization for its membership employed throughout the United States. He stressed the need for organization of the office workers in his industry and brought to our attention the fact that while in the past office workers employed in cereal and grain processing plants had been uninterested in organization, that now some of those same office workers were leaving their office jobs to take work in the mills under union conditions established by his organization.

Brother Ming spoke with such clarity and sincerity as to hold the undivided attention of the meeting. He pulled no punches but told us in straightforward language about some of the problems which we must solve in developing organization among office workers.

It was most heartening to hear Brother Ming's message on the eve of our International Conference, scheduled to open in Chicago on July 28, especially so because he and his organization have gone through many of the problems which we face in developing a strong active International Council of Office Workers.

### 11773 APPROVES STRONG RESOLU-TIONS FOR CONFERENCE

In addition to electing President Hutchings and Business Representative Probey to serve as delegate and alternate at the Chicago Conference, our local at its regular July meeting unanimously approved a group of resolutions for submission to the Conference. The resolutions deal with the reorganization of our International Council to make it a strong, helpful force to assist the 150 locals with the many problems encountered in organizing and educating office workers and in building our trade union into an organization with real bargaining power among organized "white collar workers." The regular July meeting unanimously elected President Paul R. Hutchings delegate to the International Conference of Office Employe Unions to convene at the Palmer House at Chicago on July 28. Vice President and Business Representative W. R. Probey was unanimously elected alternate delegate. The membership voted to send both delegate and alternate to Chicago because of the importance of the conference.

Brother Probey attended the Seattle A. F. of L. Convention last year as our delegate and took a most active part, together with delegates from other OEU locals, in working for the adoption of the strong resolution favoring an OEU international charter. This resolution was unanimously adopted by the convention and is largely responsible for the forthcoming Chicago Conference.

Brother Hutchings was designated, as spokesman for the various OEU delegates when they appeared before the A. F. of L. Executive Council last January to plead for the establishment of an active International Organization for Office Workers.

Our delegate and alternate plan to arrive at the Palmer House in Chicago on Sunday, July 26. They are hopeful that other delegates also will arrive early so that there will be ample time to get together, discuss, and plan for a constructive, worthwhile conference.

### FOUR NEW OEU LOCALS

According to the July issue of THE AMERICAN FEDERATIONIST, four new OEU locals have recently been chartered by the A. F. of L. These include locals at Jacksonville, Florida; Springfield, Illinois; Meriden, Connecticut; and another local at New York City.

### CLU BACKS DAVISON FOR CONGRESS

The Washington Central Labor Union is actively engaged in supporting the candidacy of Brother E. C. Davison as Congressman from the Eighth Congressional District of Virginia. The Central Labor Union has contributed to Brother Davison's campaign fund and various officers and delegates of the Central Labor Union are devoting their ceaseless efforts to assure his nomination in the Virginia Democratic Primary Election, on August 4.

Brother Davison, who is the General Secretary-Treasurer of the International Association of Machinists, is running in opposition to Congressman Howard W. Smith, who is a candidate for reelection on the democratic ticket. Congressman Smith, during his term in office, has bitterly opposed and viciously attacked organized labor and has introduced bills designed to weaken and destroy the entire labor movement.

As our membership knows, more than 125 of the members of our local are employed in the headquarters offices of the International Association of Machinists and are working under a model agreement negotiated with the Machinists' International Officers, including General Secretary-Treasurer E, C. Davison.

All members who live in Virginia are urged to vote in the Democratic Primary on August 4, 1942.

### SHOP STEWARDS TAKE NOTE

The regular July meeting adopted a motion recommended by the Shop Stewards that a regular meeting of Shop Stewards be held on the second Tuesday of each month to take up problems relating to Shop Stewards' work and for the education of the Shop Stewards. Each Shop Steward should, therefore, work this permanent date into his or her calendar. The next regular meeting of Shop Stewards will be held in the Union Office at 918 F Street N.W., at 8:00 p.m., August 11.

A motion was adopted at the July meeting upon the recommendation of the Shop Stewards to require all new applicants for membership in the union to be present at the meeting hall at 7:00 p.m. on the night when they are to be initiated into the union. The purpose of having new applicants present an hour in advance of the regular meeting time is to inform them about our union and to answer any questions which they may have. All Shop Stewards should inform each new applicant for membership to be present at 7:00 p.m. on the night of the union meeting in accordance with the action taken by the membership at the July meeting.

### MEMBERS TAKE NOTE
